PHFS OPERATES A MOBILE HOUSING RETENTION PROGRAM THAT SERVES HOMELESS FAMILIES MOVING INTO PERMANENT HOUSING. THREE FULL TIME HOUSING RETENTION SPECIALISTS WORK WITH FAMILIES WHO HAVE JUST MOVED INTO PERMANENT HOUSING AND THEN TO SUPPORT THEM FOR SIX TO TWELVE MONTHS AFTER THEIR MOVE. THE SPECIALISTS WORK TO ENSURE THE FAMILIES ARE STABLE BY PROVIDING CASE MANAGEMENT AND LIFE SKILLS TRAINING. THIS PROGRAM SERVED 507 INDIVIDUALS DURING THE 2015-16 FISCAL YEAR.

THE GOOSE HOLLOW FAMILY SHELTER IS OUR NIGHT SHELTER THAT IS OPEN FROM 6:30PM-7:30AM EVERY DAY OF THE YEAR. HERE FAMILIES RECEIVE DINNER, SHOWERS, LAUNDRY, COMPUTER ACCESS, STORAGE FOR THEIR BELONGINGS, SLEEPING SPACE, BREAKFAST IN THE MORNING AND EDUCATIONAL ACTIVITIES FOR CHILDREN AND THEIR PARENTS IN THE EVENING. IN 2015-16, WE SERVED 159 INDIVIDUALS AT OUR NIGHT SHELTER. WE HAVE 669 ACTIVE VOLUNTEERS WHO PROVIDE US WITH ABOUT 11,000 VOLUNTEER HOURS EACH YEAR. THE VOLUNTEERS WHO COME TO THE SHELTER MAKE SURE THAT THE FAMILIES WE SERVE ARE PROVIDED WITH A COMMUNITY TO SUPPORT THEM. EVERY DAY, FAMILIES HAVE THE SUPPORT OF AT LEAST 8 VOLUNTEERS THAT CAN LISTEN TO THEM TALK ABOUT THE HARDSHIPS - OR THE SUCCESSES - OF THEIR DAYS AS WELL AS HELP THEM FILL OUT APPLICATIONS FOR APARTMENTS OR BUILD THEIR RESUMES.

PHFS OPERATES A DAY SHELTER FOR HOMELESS FAMILIES WITH CHILDREN. THE THIRTEEN SALMON FAMILY CENTER IS OUR DAY SHELTER THAT IS OPEN FROM 8AM-6PM; HERE, OUR FAMILIES RECEIVE SNACKS, LUNCH, SHOWERS, COMPUTER ACCESS, AND THEY WORK WITH A HOUSING SPECIALIST TO TRY TO FIND PERMANENT HOUSING. IN 2015-16, WE SERVED 159 PEOPLE FROM 45 FAMILIES AT THE DAY SHELTER. EIGHTY NINE PERCENT OF OUR FAMILIES FOUND PERMANENT HOUSING BEFORE THEY LEFT SHELTER. TO ASSIST FAMILIES IN FINDING PERMANENT HOUSING AND ACHIEVING SELF-SUFFICIENCY, WE TEACH LIFE SKILLS IN CLASSES ON BUDGETING, PARENTING, TENANT EDUCATION, AND EMPLOYMENT.
